## 2012 FINANCIAL ASSISTANCE FOR CAMP KEE TOV

**DEADLINE: MARCH 30, 2012**

**Who funds Camp Kee Tov financial aid?** Financial assistance for Camp Kee Tov scholarships comes from two sources: the Congregation Beth El-Camp Kee Tov Scholarship Fund and the Jewish Community Foundation of the Greater East Bay's Summer Camp Scholarships Fund. A lay committee makes the award decisions and the process is anonymous.

**INSTRUCTIONS: You must register for camp at [www.campkeetov.org](http://www.campkeetov.org) before applying for a campership.**

Scholarships will cover camp tuition and associated before or after care.

- Make sure to submit an individual child form for each child in the family that will be attending camp.
- Attach a signed copy of **the first two pages of your 2011 federal tax return**  
**OR** if you have not filed your 2011 federal tax return, a signed copy of **the first two pages of your 2010 federal tax return**  
**OR** if you don't file: include statements from all sources of income for 2011 including AFDC, trust, unemployment, family support or outside agency financial assistance etc.
- Please note the Camperships Committee can not review incomplete applications.
